DIRECTIONS

To be completed each term the Disability Resource Center determines a financial aid accommodation for a student is reasonable.

—The cost of attendance will be changed, and the student’s financial aid eligibility may be revised.

—Students eligible for a Federal Pell Grant or Minnesota State Grant will only be eligible for the amount of credits they are actually registered for that term. No exceptions will be made.

—Federal loans, UTFL, SEOG, and U Promise require an enrollment status of at least 6 credits.

—Accommodation requests that are related to a reduced credit load will only be accepted by the Office of Student Finance until the end of the second week of each term.

—If you make changes to your enrollment, the accommodation may no longer apply.
